

## Foundation HIV/AIDS Grants

African Comprehensive HIV/AIDS Partnerships	Grant: \$50,000,000.00 Term: 60 Months, 2000	This comprehensive project's focus is on improving the prevention of HIV infection along with significantly increasing the rates of diagnosis and treatment of HIV/AIDS. The project will be carried out in Botswana by an alliance of private companies, including Merck, foundations, government and non-government agencies.
Africare	Grant: \$1,996,750.00 Term: 36 Months, 1999	This initiative focuses on strengthening and replicating the most effective community-based reproductive health programs for adolescents in four countries hardest hit by the HIV/AIDS pandemic: Zimbabwe, South Africa, Malawi and Zambia.
CARE	Grant: \$1,500,000.00 Term: 36 Months, 1998	The Ghana project provides family planning and reproductive services to approximately 120,000 high-risk miners and mine industry health workers in Wassa West, a district of western Ghana. The program trains peer educators already working in HIV/AIDS. The Honduras project will initiate a reproductive health program in the Sula valley of Honduras that has the largest concentration of factories (500) in the country.
Columbia University – School of Public Health	Grant: \$160,000.00 Term: 36 Months, 1998	A three-year grant for the implementation of a integrated family planning HIV/STD prevention service for Ugandan women. The project goals include doubling contraceptive prevalence (from 8% to 16%) and to provide integrated services to 100 rural communities.
DKT International, Inc.	Grant: \$4,302,367.00 Term: 48 Months, 1999	A four-year grant to reduce infant mortality and HIV transmission among adolescents through the expansion of DKT's social marketing programs.
Eastern Virginia Medical School	Grant: \$25,000,000.00 Term: 60 Months, 2000	A grant to fund additional research on the feasibility, safety, and efficacy of several promising products with both antimicrobial and contraceptive properties.
Elizabeth Glaser Pediatric AIDS Foundation	Grant: \$15,000,000.00 Term: 36 Months, 2000	In September 1999, the Elizabeth Glaser Pediatric AIDS Foundation issued a Call to Action for programs to support and enable mothers to reduce maternal to child transmission of HIV. Working in coordination with Ministries of Health, local health care agencies, NGOs, and other partners in the countries most dramatically affected by the HIV epidemic, this program will support the implementation of coordinated activities to improve access and use of anti-retroviral interventions, which will contribute to the improvement of mother/child care.
Francois-Xavier Bagnoud US Foundation	Grant: \$300,000.00 Term: 36 Months, 2000	To develop a community approach for the adoption of safe sexual behavior to halt the increasingly rapid spread of HIV/AIDS and other sexually transmitted diseases in Rajasthan, India.

Funders Concerned About AIDS	Grant: \$20,000.00 Term: 12 Months, 2000	To support the work of FCAA to address the new and remaining challenges HIV poses to all individuals and communities in this country.
Harvard University	Grant: \$25,000,000.00 Term: 60 Months, 2000	A four-part prevention program that combines collaboration, field research, intervention, and education to contain and diminish the rising AIDS epidemic in Africa's most populous country, Nigeria.
Health Systems Trust	Grant: \$7,000,000.00 Term: 36 Months, 2000	loveLife is a national strategy to reduce the incidence of HIV infection among young South Africans. The strategy combines broad-based awareness and education efforts, with adolescent reproductive health service development, and outreach.
International AIDS Vaccine Initiative (IAVI)	Grant: \$25,000,000.00 Term: 60 Months, 1999	IAVI plans to accelerate the development of globally effective AIDS vaccines. Applied research projects will fill critical gaps in knowledge related to AIDS vaccine development. These will be undertaken through contracts to research laboratories and will fall into three categories: vaccine design studies; clinical infrastructure studies; and non-human primate studies. The other component is to help ensure global access once a vaccine is available.
International AIDS Vaccine Initiative (IAVI)	Grant: \$1,500,000.00 Term: 36 Months, 1998	Support for IAVI to develop a safe and effective AIDS vaccine within 10 years. Partnerships with industry will be formed to focus simultaneously on the development and testing of several vaccine candidates that are specifically designed to target the AIDS strain found in a specific country or region.
International AIDS Vaccine Initiative (IAVI)	Grant: \$100,000,000.00 Term: 60 Months, 2001	To support IAVI's comprehensive scientific agenda. IAVI plans to establish four to eight new vaccine development partnerships with the principal goal of initiating efficacy trials of three promising AIDS vaccines within five to seven years.
International Crisis Group	Grant: \$55,000.00 Term: 12 Months, 2001	Using the combination of quality analysis and high-level advocacy ICG will document the strong linkages between AIDS and instability and with that new analysis, play a strong advocacy role for a comprehensive international plan to combat the pandemic.
International HIV/AIDS Alliance	Grant: \$5,000,000.00 Term: 60 Months, 2000	To enable the International HIV/AIDS Alliance to strengthen and expand its assistance of community action on AIDS. The Alliance aims to catalyze support and behavior change through local NGOs and community-based organizations in order to promote social and political changes that will make individuals in developing countries less vulnerable to HIV.
International Planned Parenthood Federation	Grant: \$3,055,708.00 Term: 36 Months, 1999	IPPF and the Planned Parenthood Association of South Africa (PPASA) to strengthen and develop youth centers in nine communities in South Africa in a three-year project. The goal of the project is to provide young people with sexual and reproductive health education and services they need, and the social opportunities they want, to enable them to protect themselves from HIV/AIDS.

International Planned Parenthood Federation	Grant: \$1,492,400.00 Term: 36 Months, 1998	This project significantly expands the present youth program and provides reproductive health information, education, and services to more than one-million young people and their families in five Haitian cities and surrounding areas. By directly targeting young people, the project hopes to reduce the high incidence of sexually transmitted diseases, and AIDS.
JSI Research and Training Institute	Grant: \$322,000.00 Term: 36 Months, 1999	Funding to increase the number of organizations involved in providing reproductive health services in refugee settings. The program enables international and local NGO's to develop innovative approaches to address the unmet reproductive health needs of refugees in areas such as family planning, HIV/AIDS education and sexual and gender based violence prevention.
MexFam	Grant: \$2,500,000.00 Term: 60 Months, 1999	Funds will be used to expand the Youth (Gente Joven) Program to three additional states: Sinaloa, Nayarit, and Coahuila. The program reaches 250,000 youth to prevent unintended pregnancies and sexually transmitted diseases.
Pan American Health and Education Foundation	Grant: \$4,962,100.00 Term: 37 Months, 2000	The Pan American Health Organization (PAHO) will work in collaboration with the International Consortium for Blood Safety to improve the safety of the blood used for transfusion in the region of the Americas.
Peace Corps	Grant: \$500,000.00 Term: 12 Months, 2000	To support a five-year initiative to address the devastating health, social, and economic effects of the HIV/AIDS epidemic. Funds will be used to train 8,000 Peace Corps volunteers as advocates and educators of HIV/AIDS prevention and care.
PLAN International	Grant: \$1,000,000.00 Term: 12 Months, 2000	A grant to PLAN International, in partnership with Save the Children, CARE, and the World Conference on Religion and Peace, for the collective development of a broad partnership and plan to address the AIDS orphans crisis in Africa.
Population Council	Grant: \$4,000,000.00 Term: 24 Months, 1999	To develop, test and bring to the market a vaginal microbicide product for women. The Council's lead compound, PC-515, composed primarily of the seaweed derivative carrageenan, has proved most efficacious in blocking viral infection.
Population Council	Grant: \$450,000.00 Term: 36 Months, 1998	The Biomedical Division of the Population Council has undertaken a program to identify and screen compounds that have the ability to destroy the HIV virus.
Population Services International	Grant: \$5,000,000.00 Term: 60 Months, 1999	PSI will take three to five adolescent reproductive health programs to scale over a five-year period, using promising and proven social marketing strategies. This will allow PSI to reach more African young people with the information and products that are essential to adopting healthful lifestyles.

RFSU, Swedish Association for Sex Education	Grant: \$1,292,000.00 Term: 36 Months, 1999	RFSU, in collaboration with the Planned Parenthood Association of Zambia (PPAZ) and the Family Planning Association of Tanzania (UMATI), will establish two parallel, three-year projects in Tanzania and Zambia that will emphasize information, education, behavior change, and advocacy, working to increase male involvement in reproductive health and HIV prevention
University of the Witwatersrand Foundation	Grant: \$455,000.00 Term: 12 Months, 2000	To support the mission of the Palliative Medicine Institute in incorporating palliative medicine into mainstream health care in South Africa by establishing a curriculum for nursing colleges and training nurses to provide care for AIDS patients.
US Committee for UNFPA	Grant: \$300,000.00 Term: 12 Months, 1999	A six-month planning grant to plan a regional adolescent reproductive health program in six African countries.
US Committee for UNFPA	Grant: \$56,681,270.00 Term: 60 Months, 2000	With a particular focus on AIDS, this program supports and promotes livelihood opportunities and advocates education, responsibility, gender equity and equality, and services to sexually active youth.
World Health Organization	Grant: \$994,965.00 Term: 12 Months, 2001	To support UNAIDS action to mobilize the participation of non-governmental organizations and other members of civil society in the United Nations General Assembly Special Session preparations, meeting and follow-up.
World Population Foundation	Grant: \$690,000.00 Term: 36 Months, 1999	Funds will be used over three years to support WPF activities to improve reproductive health in developing countries. Support will be directed towards two projects: Ugandan Youth, Anti-AIDS Project and a project carried out by Planned Parenthood of Thailand to address the reproductive health needs of refugees from Myanmar.
World Population Foundation	Grant: \$1,000,000.00 Term: 12 Months, 2000	To provide general support for comprehensive and appropriate reproductive health and family planning services.
Worldwide Documentaries	Grant: \$1,000,000.00 Term: 12 Months, 1999	For the production and marketing of "A Closer Walk", a film about the global AIDS crisis.
